#### STRENGTHENING OF LINE

On 27/3/56 the Hon. Sir H. J.Hyland M.L.A. wrote the Commissioners asking what is being done to strengthen the Yarram-Leongatha line.

On 5/4/56 he was advised that "We commenced to relay portion of the Yarram line between Foster and Alberton, but due to the limited amount of funds available, it was necessary to defer the work so that more urgent relaying could be carried out on other lines.

Because of the shortage of funds, I regret it is not practicable at this stage to indicate when relaying will be resumed on the Yarram line".

On 17/4/56 the Hon. Sir H.J. Hyland, M.L.A. again wrote alleging that the line was dangerous and asked that the matter be given further consideration.

On 26/4/56 the Commissioners replied inter alia:-

"After discussion with the Chief Civil Engineer I can assure you most emphatically that the Yarram line between Foster and Alberton is not as you say in a dangerous condition at the prescribed speed limit of 30 miles per hour. We have recently forwarded our loan applications, and, as you will recollect, the final programmes for relaying are dependent on the availability of the funds.

The Commissioners do want to assure you that, apart from relaying, it is intended to intensify the reslectering and general reconditioning programmes on a State-wide basis, and consideration will be given to the Foster-Alberton section of the Yarram line in this regard".

#### APPROACH ROADS AND TRUCKING YARDS

19.

At Gelliondale on tour on 24th July the Commissioners were met by Messrs. A. P. Moore and G. A. Morgan who requested that:

- (a) the approach road on the goods side be improved. During the winter months the approach is very soft and trucks bringing in pigs to the unloading ramp are liable to bog down. Difficulty is also experienced in taking delivery of truck loads of pollard etc.
- (b) the road approach to the trucking yards be improved. It was stated that the Shire road leading to the trucking yards is very wet and difficult to negotiate.
  - (c) That some filling be provided in the trucking yards.

The Commissioners pointed out that they were not responsible for the maintenance of the Shire road but they proposed to spread some gravel to improve conditions between the road formation and the heavy duty ramp.

In view of the small amount of traffic handled at the goods siding the Commissioners were not prepared to incur any expenditure on the approach road on the goods side.

The question of providing some filling in the trucking yards would be looked into.

Necessary improvements have been carried out in the area between the road formation and the loading ramp and filling has been provided in the trucking yards where required.

#### ELECTRIC LIGHTING

SHEEP YARDS

23

Requests have been made on several occasions for electric lighting to be installed at this station.

The requirements of the public are attended to mostly during daylight and it is only on rare occasions that trains are handled during darkness. A tilley lamp is provided for use in the office when necessary and the installation of electric lighting is not warranted. All requests have been refused.

When the matter was mentioned on tour on 24/7/56 the Commissioners informed Cr.V. Wood of the Shire of South Gippsland and Mr. J. Gunn of the local Progress Association that in view of the financial difficulties facing the Railways during the current year they were unable to undertake the work of providing electric lighting at the station.

#### CHILDREN'S PLAYGROUND

24.

On 28/2/56 the Welshpool Progress Association wrote the Secretary for Railways requesting the lease of a piece of land 140' x 118' on which the Association desired to provide a children's playground.

The land desired is at present leased to the Lands Department and its proximity to the siding makes its conversion to a children's playground undesirable from a safety point of view.

#### APPROACH ROAD TO TRUCKING YARDS

33.

"At Toora on tour on 24th July 1956 representations were made to the Commissioners by Councillor A. Lonsdale of the Shire of South Gippsland, in regard to the approach road to the trucking yards.

It was stated that, owing to the heavy traffic to and from British United Dairies, there is serious congestion when stock is driven to the trucking yards from the roadway at the 'down' end. There is a road half a chain wide at the 'up' end leading towards the trucking yards which could be used for stock.

The Commissioners pointed out that the congestion was caused by the concentration of road traffic and they could not see their way to incur the expense that would be involved in providing the approach. The half chain roadway did not belong to the Department but appeared to be a Council road, and, if those concerned wished to use it as an approach to the trucking yards, it would be necessary for the Council to bear the cost.

However, if the Council submitted a proposition the Commissioners would be prepared to look into it".

#### FENCING.

"With reference to your letter of 15th June, the fencing of the railway land between Hoddle and Foster has been inspected, and approximately 2 miles requires renewal, and repairs are necessary to other sections.

Departmental staff is not available to carry out the work and the necessary material is on hand, but we have been unsuccessful in obtaining contractors to do the work. We are, however, again inviting tenders with a view to having the repairs and renewals effected as early as practicable.

I might mention that the Commissioners are not obliged to maintain the fences, but they do so for their own purposes. The legal responsibility for repairs to the fencing in question rests with the adjoining landholders, and they might co-operate by submitting tenders for the work."

#### OCCUPATION CROSSING AT 100M. 56 Ch.

At Hoddle on tour on 27/4/55 representations were made to the Commissioners by a deputation comprising Messrs. J. Pritchard J. Stewart, and F. McInnes that some improvements be made to the view at this crossing.

It was stated that the view is particularly restricted, that several "narrow misses" have occurred and that every school day children are conveyed by notor car over the crossing.

The deputation was informed that the crossing is an occupation one, that the view could be improved by reducing the height of the banks of the cutting, and that the Obmmissioners regretted they could not see their way to bear any portion of the cost that would be involved.

The deputation expressed the view, however, that unless a very large amount of earth were removed, the view approaching trains would still be very restricted, and they asked whether consideration would be given to the provision of an overhead bridge.

# HODDLE & FISH CREEK (Contd.)

#### OCCUPATION CROSSING AT 100M. 56Ch.

They were informed that while the Commissioners would be glad to look into the matter they would not be willing to bear any portion of the cost.

At the request of the deputation an inspection was subsequently made at the crossing, and it was evident that the provision of an overhead bridge (which would involve raising the telegraph lines) would be very costly.

The deputation was informed that the only practicable way to improve the existing conditions would be to reduce the height of the embankments, and, after discussion those concerned agreed.

Mr. Pritchard said he had a bull-dozer on his farm which could be used for the purpose of lowering the embankments, and that as soon as those concerned were prepared to go on with the work the Department would be advised so that the necessary arrangements could be made for the disposal of the spoil.

Nothing further has transpired in the matter.

In 1955 it was considered that the yards were in reasonably good order and that no major renewals would be required for at least 5 years.

However, in view of the heavy rainfall in this area, a scheme was prepared for concreting the sheep crush yards and providing a concrete lined drain between the crushes and the holding yards.

The matter was mentioned at Fish Creek on tour on 24/7/56 when Cr.W. Gale of the Shire of South Gippsland and Messrs Ryan and Kerr were informed by the Commissioners that the sheep crushing yards and race would be surfaced in concrete and the pitchers re-set in the cattle race.

On 2nd January, 1958, International Packers Pty.Ltd. wrote to the Estate Officer suggesting an enlargement of the holding and loading facilities for cattle and pigs and the matter is being investigated.

#### REALIGNMENT OF CURVES.

85.

On tour on 28.4.55 the Commissioners noted that realignment of a number of the 20 chain curves to improve the curvature appeared practicable involving a comparatively small amount of earthworks, and desired that an exploratory investigation be carried out to determine approximately the cost involved and if any improvement in schedules would result.

Investigation revealed that the present curves restrict speed to 30 m.p.h., but this could be increased to 40 m.p.h. by realignment of approximately  $1\frac{3}{4}$  miles of track, although very heavy earthworks would be required at an estimated cost of £300,000.

The Chief Traffic Manager reported on 23.12,55 that as similar track conditions apply for a considerable distance in the heavy country on the South Eastern Line the small advantage to be gained in the area did not justify the incurring of the expenditure involved.

# FOOTWAY ON DOWN SIDE OF OVERHEAD BRIDGE AND VIEW NEAR ENGINE SHED (Contd.) 98.

On 14.1.55 the Secretary for Railways wrote the Shire Council saying "It will be practicable to provide a footpath at some future date on the down side of the new bridge to be constructed over the railway at the down end of the Korumburra station yard.

Your Council would of course require to bear the whole of the cost involved."

"There would be no objection to portion of the engine shed at this location being removed, and arrangements will be made accordingly if your Council so desires and will bear the whole of the cost, estimated at £400, involved."

The matter was raised by Cr. Riddell, President of the Shire of Korumburra when the Commissioners were on tour on 25.7.56 and the Commissioners again indicated that portion of the engine shed would be cut back if the Council was prepared to pay for the work.

No reply has been received from the Council but in March, 1957, Mrs. Decima Mayne, Town Riding Councillor, of the Korumburra Shire sought a personal interview with the Commissioners, in connection with this and other matters, through Mr. Cochrane, M.L.A., and on 21/3/57 the Secretary for Railways wrote to Mr. Cochrane "inter alia."

"The bridge is due for renewal, and instructions for the carrying out of the work are in course of preparation. Suitable provision will be made for construction of a footway by the Council, and on request the conditions under which it may be constructed will be supplied."

"In view of the position as indicated above with regard to the matters referred to, it would not appear that the proposed interview is necessary, but this will be arranged if it is still desired."

#### LEVEL CROSSING AT 65M. 32CH.

108.

During their inspection of the South Eastern line on 20.10.52 the Commissioners noted that the road users' view of approaching trains at the level crossing at 65M. 32CH. appeared to be obstructed by the adjacent departmental residence.

The Level Crossing Committee inspected the location on 20.4.53 and reported that:

"Whilst the Departmental residence is an obstruction to view of up trains (the presence of the cutting at the up end is probably a greater hazard in respect of down trains) the only persons using the crossing are residents of the two houses served by the deadend roadway who are familiar with conditions and exercise due caution."

In view of the report of the Committee the Commissioners approved of the residence being allowed to remain in position.

On tour on 28.4.55 the Commissioners were informed by the occupant of the D.R. that traffic over this crossing had increased.

At the request of the Commissioners the Level Crossing Committee made further investigations, and reported on 5.7.55 that the increased traffic had resulted from greater use being made of the crossing by the residents of the two houses previously referred to. However, this location is listed for the provision of 'Stop' signs and erection of these will be arranged as the signs become available.

#### LEVEL CROSSING AT 66M. 47CH. (WHITELAW).

109.

As a result of investigation by the Level Crossing Committee in 1945, approval was given for the abolition of D.R. 365 and the provision of cattle pits, with flashing light signals, at the level crossing at 66M. 47CHS.

It was subsequently ascertained that the road over this crossing is the regular stock route and that stock droving is prohibited along the adjacent main road, and in view of this, it was decided in 1946 that the installation of flashing light signals would be unsuitable and that, instead, a 20' wide overhead bridge be constructed some distance in the down direction in lieu of the existing crossing. However, the local Council was not prepared to assist with the necessary road formation in connection with the bridge, as it was considered the bridge would not be warranted when the Country Roads Board constructed the South Gippsland Highway on the opposite side of the line between Bena and Korumburra, which was approved by the Board in 1948.

At Bena on tour on 28.4.55 representations were made to the Commissioners by a deputation from the local branch of the A.P.P.U. that the level crossing at 66M. 47CH. at Whitelaw be abolished when the South Gippsland Highway is reconstructed. The deputation said it was understood that the Country Roads Board proposed to construct the Highway between Bena and Korumburra and asked that when this was done an overhead bridge be provided in place of the existing crossing.

109. (Ctd.)

The deputation was informed that it was understood the Country Roads Board had abandoned the proposal, but that the matter would be again taken up with the Board with a view to ascertaining what it proposed to do.

On 24.5.55 the Secretary for Railways wrote Mr.W.Dooling of Bena (member of the deputation on 28.4.55) as follows:- "I desire to say that enquiries from the Country Roads Board confirm the intimation made by my Commissioners at the time that the Board does not intend at present to proceed with the proposal to deviate the South Gippsland Highway from the north to the south of the railway line between the level crossings at 65M. 79CH. and 68M. 36C.

It is understood that reconstruction of certain sections of the highway on the present northern alignment is to be undertaken by the Board, but until such time as it becomes necessary to replace the existing gate-house at Whitelaw, my Commissioners regret they cannot see their way to accede to the request that the existing crossing be replaced by an overhead bridge. Arrangements are being made to provide a warning bell at an estimated cost of £628, to advise the gatekeeper of the approach of 'up' trains.

Filtration or chemical treatment units of a size suitable for ablution purposes are not readily available, are costly to install and require frequent cleaning".

He recommended that no action be taken to connect the tanks to the bathrooms.

On tour on 27.4.55 the Commissioners reviewed this matter and were satisfied that this water is suitable for ablution purposes, but that tank supplies for drinking and cooking should be connected to those houses at Nyora not so serviced.

By letter on 15.3.55 and on tour on 28.4.55, the Shire of Korumburra made representations that the level crossing at Yann's Road between Nyora and Woodleigh (mileage 57M. 42C.) be abolished, and an underpass (at approximately 57M. 18C) be substituted.

On 23.5.55 a letter was received from the Country Roads Board referring to this matter, and advising the estimated cost of regrading the crossing (£400) and the estimated cost of construction of a suitable underpass (£3,500) and requesting advice as to this Department's contribution to the cost.

On 21.6.55 the Secretary for Railways wrote the Secretary Shire of Korumburra inter alia: - "Our Level Crossing Committee has investigated the request that the present level crossing be abolished and an undercrossing be provided at approximate mileage 57M. 18CH. and there would be no objection by the Department to the proposal which is estimated to cost £5.500.

In response to a recent request from the Country Roads Board the latter was informed that provided the existing P.C.R. were closed this Department's contribution would be approximately £500.

The Chairman of the Inter Departmental Level Crossing Committee has intimated that conditions at this crossing are such that it would have a very low priority in any grade separation programme."
