KORUMBURRA - BENA.

LEVEL CROSSING AT 66M. 47CH. (WHITELAW).

103:

As a result of investigation by the Level Crossing Committee in 1945, approval was given for the abolition of D.R.365 and the provision of cattle pits, with flashing light signals, at the level crossing at 66M. 47CHS.

It was subsequently ascertained that the road over this corsing is the regular stock route and that stock droving is prohibited along the adjacent main road, and in view of this, it was decided in 1946 that the installation of flashing light signals would be unsuitable and that, instead, a 20' wide overhead bridge be constructed some distance in the down direction in lieu of the existing crossing. However, the local Council was not prepared to assist with the necessary road formation in connection with the bridge, as it was considered the bridge would bot be warranted when the Country Roads Board constructed the South Gippsland Highway on the opposite side of the line between Bena and Korumburra, which was approved by the Board in 1948.

At Bena on tour on 28.4.55 representations were made to the Commissioners by a deputation from the local branch of the A.P.P.U. that the level crossing at 66M. 47CH. at Whitelaw be abolished when the South Gippsland Highway is reconstructed. The deputation said it was understood that the Country Roads Board proposed to construct the Highway between Bena. and Korumburra and asked that when this was done an overhead bridge be provided in place of the existing crossing.

The deputation was informed that it was understood the Country Roads Board had abandoned the proposal, but that the matter would be again taken up with the Board with a view to ascertaining what it proposed to do.

On 24.5.55 the Secretary for Railways wrote Mr.W. Dooling of Bena (member of the deputation on 28.4.55) as follows:- "I desire to say that enquiries from the Country Roads Board confirm the intimation made by my Commissioners at the time that the Board does not intend at present to proceed with the proposal to deviate the South Gippsland Highway from the north to the south of the railway line between the level crossings at 65M. 79CH.and 68M. 36C.

It is understood that reconstruction of certain sections of the highway on the present northern alignment is to be undertaken by the Board, but until such time as it becomes necessary to replace the existing gate-house at Whitelaw, my Commissioners regret they cannot see their way to accede to the request that the existing crossing be replaced by an overhead bridge. A warning bell to advise the gatekeeper of the approach of 'up' trains is at present being installed.

By letter on 15.3.55 and on tour on 28.4.55, the Shire of Korumburra made representations that the level crossing at Yann's Road between Nyora and Woodleigh (mileage 57M. 42C.) be abolished, and an underpass (at approximately 57M. 18C) be substituted.

On 23.5.55 a letter was received from the Country Roads Board referring to this matter, and advising the estimated cost of regrading the crossing (£400) and the estimated cost of construction of a suitable underpass (£3,500) and requesting advice as to this Department's contribution to the cost.

On 21.6.55 the Secretary for Railways wrote the Secretary Shire of Korumburra inter alia: - "Our Level Crossing Committee has investigated the request that the present level crossing be abolished and an undercrossing be provided at approximate mileage 57M. 18CH. and there would be no objection by the Department to the proposal which is estimated to cost £5,500.

In response to a recent request from the Country Roads Board the latter was informed that provided the existing P.C.R. were closed this Department's contribution would be approximately £500.

The Chairman of the Inter Departmental Level Crossing Committee has intimated that conditions at this crossing are such that it would have a very low priority in any grade separation programme."

The Country Roads Board was similarly advised on 21.6.55.

Arising out of representations made to the Commissioners on tour on 25/7/56 and advice that the Council was anxious to proceed with the work, the Commissioners agreed to the Department's contribution being increased to £750 and in response to its request for an up-to-date estimate of the cost of providing the underpass the Shire of Korumburra was advised on 16/11/56 that the figure was then £9,350.

Replacement of the open P.C.R. crossing at Yann's Road 57M. 42C. between Nyora and Woodleigh by an underpass structure was raised by the Shire with the Minister for Public Works in June, 1957.

After discussion it was agreed that the road, which is a Shire responsibility, carries only very light traffic and that there was no justification for according it any priority or the use of Level Crossings Funds for the purpose.

BOUNDARY FENCING, LEASE OF LAND.

138.

On tour on 28/4/55 representations were made by the Shire of Bass that the railway enclosure, which was very much wider than normal for a considerable distance, be reduced to the usual width and the balance sold or leased to adjoining landowners.

Enquiries disclosed that the sidewidths of the railway enclosure were one chain (the normal width) and that there was no surplus land available for sale.

The question of the Department leasing sidewidths to adjoining landowners was referred to by Mr. D. Lorimer at Glen Forbes on tour on 12th February 1958. He stated that railway sidewidths, unless burnt off early, become breeding places for caterpillars, but if landowners were permitted to move their fences close to the line this trouble would not occur.

In the circumstances it was regretted the request could not be acceded to, nor were the Commissioners prepared to allow landowners to move their fences close to the railway tracks.

FOOTWAY ON DOWN SIDE OF OVERHEAD BRIDGE AND VIEW NEAR ENGINE SHED.

On tour on 28.4.54 representations were made to the Commissioners by a deputation from the Shire of Korumburra that when the overhead bridge on the Down side of the station was being constructed provision be made for the construction at a later date of a footway on the down side.

The deputation stated that with the increasing traffic over the bridge pedestrians are being submitted to serious risk and that while the Council could not undertake the provision of a footway at this stage it proposed to so so at a later date.

Attention was also drawn to the dangerous conditions involved in negotiating the corner near the engine shed and it was asked whether the engine shed could be cut back so as to afford a better view for drivers of road vehicles.

It was pointed out to the deputation that the proposed improvements are apparently necessary because of the developing road traffic in the vicinity and that in such circumstances the cost involved would require to be defrayed by the Council. The matter would be investigated and the Council advised as to the costs that would be involved in complying with its request.

On 14.1.55 the Secretary for Railways wrote the Shire Council saying "It will be practicable to provide a footpath at some future date on the down side of the new bridge to be constructed over the railway at the down end of the Korumburra station yard.

Your Councik would of course require to bear the whole of the cost involved."

"There would be no objection to portion of the engine shed at this location being removed, and arrangements will be made accordingly if your Council so desires and will bear the whole of the cost, estimated at £400, involved."

The matter was raised by Cr. Riddell, President of the Shire of Korumburra when the Commissioners were on tour on 25.7.56 and the Commissioners again indicated that portion of the engine shed would be cut back if the Council was prepared to pay for the work.

FOOTWAY ON DOWN SIDE OF OVERHEAD BRIDGE AND VIEW NEAR ENGINE SHED. (contd.)

In March 1957, Mrs. Decima Mayne, Town Riding Councillor, of the Korumburra Shire sought a personal interview with the Commissioners, in connection with this and other matters, through Mr. Cochrane, M.L.A., and on 21/3/57 the Secretary for Railways wrote to Mr. Cochrane "inter alia."

"The bridge is due for renewal, and instructions for the carrying out of the work are in course of preparation. Suitable provision will be made for construction of a footway by the Conncil, and on request the conditions under which it may be constructed will be supplied."

"In view of the position as indicated above with regard to the matters referred to, it would not appear that the proposed interview is necessary, but this will be arranged if it is still desired."

On 4/6/58 the Shire wrote advising that it was anxious to have a footpath provided on both sides of the bridge and on 16/7/58 the Secretary for Railways replied that the estimated cost of £1,585 would require to be met by the Council. In reply to a further letter from the Council the Secretary for Railways replied on 5/9/58 pointing out that the Commissioners, who had been directed by State Cabinet that they are not to contribute to such Works, were not prepared to bear any portion of the cost of the bridge works desired by the Council.

DRAINAGE TRUCKING YARDS.

95.

At Korumburra on tour on 25th July 1956, representations were made to the Commissioners by Councillor H. Dowell, Shire President and the Shire Engineer, in regard to the drainage from the livestock trucking yards.

It was stated that drainage from the yards is flowing under the adjoining road and into the Council's sale yards. The Council was prepared to provide, at the Department's cost a concrete channel along the southern side of the trucking yards (a length of approximately 150 ft.) at 10/- per foot.

The Commissioners pointed out that all the drainage involved was not coming from the trucking yards, but that they would be prepared to contribute 50 per cent of the cost of the proposed channel, if the Council contributed the other half.

The Council representatives stated that they considered this offer would be acceptable, and that it would be submitted for early approval and the decision conveyed to the Department in the next week or so. It was agreed that the Council would maintain the channel.
