Byrnes, M.L.C. on behalf of the Borough of Swan Hill which desires the land for civic and recreational purposes at a nominal rental. It was intimated that the Council was preparing a planning scheme which would prevent the proposed tenant using the premises for the desired purpose.

In replying to Mr. Byrnes on 1/4/57, the Minister of Transport pointed out, 'inter alia', that due to the past liberality of the Department, over 20 acres of railway land in the vicinity of Swan Hill station had been leased to the Borough at nominal rental. Gardens, swimming pool, tennis courts and other public amenities had been established on this land and it could not be denied that the Department had contributed greatly to the civic development of the town by making the land available.

In addition, the Department had leased to the Council for beautification purposes an area having a frontage of 485 ft. to Curlewis Street. A peppercorn rental is charged for this land but on the basis of the tender submitted for the land in question, the rental value would be £1,261 per annum.

Also, in 1954 the Commissioners agreed to legislation transferring to the Council land having a frontage of 297 ft. in Curlewis Street in return for land away from the centre of the town on which pre-cut houses were subsequently erected. The express purpose of the exchange of land was to enable that in Curlewis St. to be used as a civic centre.

In view of the foregoing, it is considered reasonable that the Council should review its attitude to the matter.

To test its attitude in the matter, the Council was offered on 6/6/57 a lease of the land at the same rental as that offered by O'Connell Motors (£104 per annum). The offer was refused.

Mr. O'Connell was written to on 13/10/59 and requested to advise whether he is still interested in leasing the land in question.

If so, it is proposed to lodge appeal against the Council's zoning plan to the Minister of Public Works.

Between Molan St. gates at North Bendigo and Maglehawk a distance of 34 miles, there are eight level crossings, one footbridge, one pedestrian subway and five foot crossings.

On 8.10.59 the Commissioners approved that the following work be carried out:-

- 2. Installation of flashing light signals at:-

BRIDGE OVER RAILWAY AT MYRTLE STREET

138.

At Bendigo on tour in October, 1955 representations were made on behalf of the City of Bendigo that the bridge over the railway tracks at Myrtle Street be straightened and widened.

It was stated that the alignment of the bridge to the road on either side caused two extremely had angles making it a danger to road traffic, and contended that the unsatisfactory conditions at the bridge had been accentuated when it was extended some years ago. On 4th November, 1955 the Commissioners advised the Council they were satisfied that the conditions at the bridge referred to had not been worsened by the provision of the additional span at the Russell Street end of the Bridge where the approach was considered to be on a reasonable curve and level. (Contd.)

Subsequently the Council proposed an alteration to the alignment of the parapet on the Bendigo side of the bridge and the provision of a pedestrian footbridge on the North side of the existing bridge. The Commissioners were not however prepared to undertake the provision of the footbridge but indicated their willingness to contribute 50% of the cost of widening the Russell St. approach which was estimated to involve an expenditure of £1,830.

The Commissioners again discussed the matter with representatives of the Council at Bendigo on 12th April, 1956, and at their suggestion it was agreed by the Council representatives that conditions would be improved if the Department removed the brick parapet at the North Western end and erected a chain wire fence thereby enabling the roadway to be widened by about 18" and the curve eased. This would at the same time improve the view of the drivers of cars coming from the west. It was promised that this would be done quickly and that, if after the altered conditions had been in operation for some time the Council considered further improvements were necessary, the Commissioners would be prepared to again discuss the matter. The parapet has since been removed and the wire fence erected.

This matter was again referred to by representatives of the City of Bendigo on tour on 14.2.57, when the bridge was inspected in company with members of the deputation and it was agreed that an estimate of cost of providing a separate footway from the southern end of the original bridge towards Russell Street would be prepared and the Council advised. The suggestion was made than an improve ment would be effected if the parapet on the Western side of the bridge at the North end were replaced by a chain wire fence.

On 9.10.57 the Secretary for Railways advised the Council as follows:-

"I attach a plan showing the location of the proposed footbridge adjacent to the road bridge over Myrtle Street, Bendigo and the proposed widening of the roadway at the southern end of the bridge.

The estimated cost of the work is as follows: -

- (1) Footbridge £4,500 excluding approach earthworks, fencing and paving, and
- (2) Widening of roadway at the southern end £740.

The cost of providing chain wire fencing in lieu of the parapet at the North Western corner of the bridge is £100.

As these works are not required for railway purposes, my Commissioners regret they are unable to bear any portion of the cost involved.

In reply to representations by Hon C.P. Stoneham M.L.A. the Hon. the Minister for Transport replied on 14.11.58, setting out the policy of the Government in regard to the use of Railway and other loan funds for capital works and indicating that the footbridge requested was certainly not required by the Railway Department and in the circumstances it would appear that the matter is one for the City of Bendigo to either finance itself or take up with the Country Roads Board, but it was certainly not a matter for the Railway Department.

LAUREL ST. UNDERPASS

144.

In August, 1958 representations were made to the Minister by Mr. Arthur Smith M.L.C. on behalf of the Head Master and School Committee of Golden Square State School for improvement in connection with the safety of children using the Laurel Street underpass and on 23rd October the Chairman advised the Minister as follows:

"The Commissioners have to report that the railway bridge over the roadway at Laurel Street, Golden Square, is of single brick arch type with a span of 25 feet. The roadway under the bridge has been sealed but footpaths have not been provided, as the relatively small span of the bridge apparently prevented the provision of suitable pedestrian access after sealing for road traffic.

It has been ascertained that the Committee and the Head Teacher of the Local State School are seeking the provision of a pedestrian subway on the "up" side of the bridge to protect school children now using the underpass.

This Department is under no obligation to provide a subway or otherwise to improve conditions for traffic through the bridge especially where the altered conditions which exist vize, the increased speed and volume of road traffic, has been brought about by circumstances beyond the control of the Commissioners (Contde)

GOLDEN SQUARE (CONTD.)

LAUREL STEET UNDERPASS (Contd.)

In any case, the provision of such a subway would be so costly that it is considered unlikely that anybody would be prepared to incur the heavy expenditure involved.

A pedestrian subway exists at Maple Street about 9 chs. in the "up" direction from the underpass in question about 2 chs. from the rear of the school property. At present any children using this subway to gain access to the school would require to follow a somewhat circuitous route by way of Laurel, Panton and Maple Streets, and this no doubt accounts for the use made by the children of the Laurel Street facility.

A possible solution to the problem would be the construction of an adequately fenced pathway on railway land between the "up" end of the school grounds and the Maple Street subway subject of course to the children being required to use such pathway instead of the underpass.

If this proposal is brought to the notice of the parties concerned the Commissioners desire that it be on the distinct understanding that:-

- such footpath is to be constructed and maintained without cost to this Department and to its satisfaction by some responsible body such as the local Council or the Education Department.
- the responsible body will at its cost construct and maintain an effective fence between footpath and the balance of railway property.
- such responsible body will be required to execute an agreement covering the existence, maintenance and user of the footpath and fence on railway land.

Alternatively, it would probably be possible to eliminate the pier and thus provide a 30 ft, opening for the roadway and if the Council is interested the proposal will be further investigated and an estimate of cost prepared.

Any work mecessary to improve road traffic conditions is the responsibility of the road authority and Commissioners would not be prepared to incur any expense in either proposal.

BRIDGE AT WHEELER STREET

162.

On tour on 12/6/52 representations were made to the Commissioners by the Mayor the Town Clerk and the City Engineer that the bridge over the railway at Wheeler Street should be widened.

The Deputationists were informed that as the necessity for the additional roadway had apparently arisen from the development of road traffic, it was only reasonable that the Council should bear the cost, if the bridge had to be widened because of the development of railway traffic the Department would not ask the Council to contribute.

On 29/7/52 the Town Council was advised that the cost of affixing a 5 feet footpath to the bridge, including an amount to cover the capitalised cost of maintaining the facility was estimated at £625.

Further representations in regard to this matter were made to the Commissioners by the Mayor when they were at Castlemaine on tour on 29th October, 1954 and a request made that the Commissioners should undertake the work at their expense because of the poor state of the Municipality's finances. The Commissioners replied that the necessity for the additional roadway had apparently arisen from road traffic development and they regretted they could not depart from their general policy in such cases.

On March 4th, 1957 the Town of Castlemaine wrote asking that whilst Railway Workmen were engaged on the Wheeler Street bridge the widening of the bridge should be undertaken. The Secretary for Railways replied on 19th March that the work being carried out was of a maintenance nature only and re-affirmed that the cost of widening the bridge should be borne by the Council.

The matter was again mentioned on tour on 9/5/57 and after inspecting the bridge, in company with Councillors R.T.Morrissey (Mayor) and J. Sheehan, and the Engineer of the Town of Castlemaine, the Commissioners again indicated that having regard for the fact that the desired improvement was the result of road traffic development they could not see their way to bear any portion of the cost. In a period of 7/8 minutes that the Commissioners were at the bridge, no vehicle passed over it. (52/6156)

BRIDGE AT 79Me 22Co

163.

At Castlemaine on tour on 9th May, 1957 representations were made to the Commissioners by Crs. R. T. Morrissey (Mayor) and J. Sheehan, and the Engineer of the Town of Castlemaine, that conditions be improved to bridge at 79M. 22C. over Castlemaine-Maryborough line (Bridge was referred to by the deputation as Laurence Street Bridge but is known departmentally as Redfern St.)

Inspection disclosed that the Council had allowed the road approaches and the surface of the bridge to fall into a state of disrepair. In reply to a letter of February 6th 1959, regarding the operation of the crossing gates at Elphinstone station, the Secretary for Railways wrote to the Secretary, Skire of Metcalfe on 13th March 1959 as follows:

"I desire to say that, in view of the complaints received, the working of the hand operated gates at the Elphinstone level crossing has been investigated.

ELPHINSTONE (Contd.)

The gates in question are located 95 yards from the station office and are normally open for the passage of road traffic, and it is necessary for them to be closed across the roadway by the signalman before the fixed signals are placed at the proceed position for an approaching train.

Owing to the curvature of the line, however, the view of approaching trains is restricted, and the signalman can anticipate the arrival time of goods trains only from the time the departure signal is received by him from the adjoining signalling point.

The times taken by "up" goods trains in running between Castlemaine and Elphinstone vary to some extent according to the load conveyed, the engine power provided and the prevailing weather conditions, and some delay in reopening the gates to road traffic is unavoidable in the event of an approaching train exceeding the usual running time for the section.

Instructions issued to the staff responsible for the operation of the gates provide for this duty to be performed in such a manner as will cause the minimum delay to road traffic, consistent with safety and reasonable railway requirements and, having regard to the difficult conditions at that location, it would appear that everything practicable is being done to minimise such delays",

At Kyneton on tour in June 1956 Mr. S. D. Gilmore, stated that the unloading of trucks of coal, coke, pig iron and sand would be facilitated if delivery of these commodities could be taken at the siding on the up side of the station. Hon. R.T. Pollard, M. H. R. who had previously drawn attention to this crossing, on 11/4/57 requested the provision of flashing light signals. Consideration was given this request but the provision was not considered justified having regard for conditions at other crossings and Mr. Pollard was informed accordingly. Following protracted negotiations with the adjacent landowners and the Shire of Newham and Woodend certain improvements were effected including the removal of 350 ft. of hawthern hedge and the position at the crossing is safisfactory.

STATION APPROACH ETC.

213.

At Woodend on tour on 9th May, 1957 representations were made to the Commissioners by Councillor V.C. Wilson and the Secretary of the Shire of Newham and Woodend that:-

- (a) The approach road on the 'up' side be re-scaled;
- (b) The ditched gutter be flattened out to make access to the station entrance easier for motor vehicles;
- (c) The footpath at the south end of the goods shed be sealed and that it be continued across the approach yard to the station entrance;
- (d) The lighting of the pathway referred to in (c) be improved.

The Commissioners inspected the area and informed the deputation that the approach road was in reasonable condition, but the question of giving it another coat of bitumen and screenings would be reviewed next summer. In view of its present condtion, however, it was unlikely that additional expenditure on the area would then be authorised.

Unless vehicles approach the station entrance at excessive speeds no difficulty would be experienced in crossing the ditched drain, Observation of a car and a truck while the Commissioners were on the spot confirmed this.

It was pointed out that the only place a path could be provided would be along the side of the entrance road, and it was most unlikely that it would be used when pedestrians could take a short cut across the roadway to or from the station.

The gravelled footpath at the south end of the goods shed was found to be in reasonable condition, but conditions at night would be improved by the provision of a stronger globe in place of the present light.

It was intimated this would be done, but the Commissioners regretted they could not see their way to accede to the other requests.

The light referred to has been fitted with a 150 watt globe and a new shade.

When the Commissioners were at Woodend on tour on 13th November, 1958, they were again asked by representatives of the Shire of Newham and Woodend to have the ditched gutter flattened or abolished and that an additional light be provided to illuminate the approach road on the up side.

CROSSING AT 34m. 38ch.

In 1951 the Soldier Settlement Commission requested that the "occupation" crossing at 34.m 38.ch be converted to a P.C.R. but after investigation the Commissioners decided to retain the crossing as an "occupation" crossing but certain earthworks were carried out in 1953 to ensure adequate views of approaching trains at this point.

In 1955 Mr. H. Kane, M.L.A. made further representations to have the "occupation" crossing converted to a level crossing but the request was again refused by the Commissioners after further investigation by the Level Crossing Committee.

In reply to further representations made at Riddell on tour on 13/11/58, The Commissioners explained that large sums of money are being spent each year on the abolition of level crossings and their policy, in the interests of safety, is to reduce rather than to increase the number of open crossings, particularly on lines where trains travel at high speeds. The necessity to open and close the gates offers some measure of safety to users and it was regretted they could not see their way to accede to the request.

The Commissioners were met on tour at Clarkefield on 13th November, 1958 by a deputation comprising Councillor Sullivan (President) of the Shire of Bulla, Councillors S. Amess, and B. Brady of the Shire of Romsey and a number of local residents when it was again urged that an overhead bridge be provided at Clarkefield.

The Commissioners replied that the bridge was not required because of any increase in rail traffic but solely due to the development of settlement. The Government has laid down that where a facility is required owing to an increase in road traffic or any other reason not brought about by railway requirements, the cost of such facility must be borne by other than railway funds.

In reply to a question of whether the Commissioners would agree to the provision of level crossing protected by flashing lights it was pointed out that the Commissioners were averse to increasing the number of open crossings.

On 1st December, 1958 the Secretary for Railways wrote to the Shire of Romsey as follows:-

"With reference to the recent discussion when the Commissioners were at Clarkefield regarding the preparation of a plan of a bridge over the railway near the station, I desire to say that a plan was prepared several years ago at the request of then Minister of Transport.

The plan is not a structural one but shows the site of the suggested bridge and the approaches. Its preparation was necessary to estimate the work involved in the proposal. Subsequently, a copy of the plan was forwarded to the Soldier Settlement Commission, at its request, so that your Shire could plan its roads in the Clarkefield Soldier Settlement Estate.
