SPUR LINE TO INDUSTRIAL ESTATE

2.

On the 11th. May, 1975 the Shire of Warragul stated that the Council has developed an Industrial Estate on the North side of the line and have asked if there is a possibility that the Railways would construct a Spur Line to provide container handling facilities.

The General Manager pointed out that it was unlikely that the Railways would construct a Spur Line but added that a Private Siding into the area could be the answer.

Following investigation by the Chief Design Engineer, the District Engineer and the District Superintendent, it was found that the Council owns land adjacent to the Railway Reserve on the North side and it is feasible to provide rail access by a Siding worked within the station limits.

Arrangements are being made to develop a planning proposal, in conjunction with the Planning Division, for long term rail facilities in the area.

It is proposed to reconstruct the road over rail bridge at Peterkin Street with four 12 Feet 6 Inches diameter Armco corrugated metal pipes.

A fixed amount of \$10,000.00 has been contributed towards the reconstruction of the sealed roadway between Peterkin Street and Campbell Street where an unformed roadway now exists and Council has been requested to close the roadway under the bridge and transfer the land.

TOWN PLANNING SCHEME

23.

A number of objections were made to the Sale Planning Scheme when it was on exhibition late in 1975. Some of these objections have been allowed, either wholly or in part.

PROPOSED RE-ALIGNMENT OF PRINCES HIGHWAY P.C.R. CROSSING AND PROVISION OF FLASHING LIGHTS. 34.

On 20.10.75 the Country Roads Board were forwarded a preliminary sketch showing the existing facilities at the Level Crossing at Princes Highway, Nicholson, 175M. 11C. 37LKS., where it is proposed to install flashing light signals and were requested to inform us of their road alignment requirements.

The Country Roads Board on 12.2.76 forwarded a copy of their drawing showing the proposed re-alignment of the Crossing which also incorporated their portion of the work which includes the earthworks and road and paving works.

They were further advised on 14.4.76 that the flashing light signals are programmed for installation in November/December, 1976 and installation will need to be carried out in conjunction with road works and the road re-alignment should be scheduled to permit this work to be commenced at this time.

The Country Roads Board advised us in their letter of 30.6.76 that the detailed plan submitted to them was satisfactory. Subject to amendments to the drainage, however, the Board has not yet allocated funds for the project and deferment to a mutually agreeable date is necessary.

TRAFFIC CONTROL AT THE TRAMWAY ROAD LEVEL CROSSING
